THE FREDERICK RAKESTRAW LAW SCHOLARSHIP APPLICATION

This scholarship fund was created to provide scholarships for qualified college graduates pursuing a Degree in Law, who were residents of Fulton County Indiana for at least three (3) years during his/her high school career (Grades 9-12), who have been accepted into a graduate school program and are enrolled in any School of Law in the United States.

All first-year recipients must submit to the Northern Indiana Community Foundation a copy of his/her acceptance letter or other proof of enrollment from any School of Law in the United States when applying for this scholarship.

This scholarship may be renewed by re-applying for the scholarship each year during such student's graduate studies education, subject to the availability of sufficient funds and only if the recipient maintains eligibility requirements. Recipients who are re-applying and any new applicants who are applying for the first time will be given equal consideration in the selection process. **To apply for renewal of said scholarship, recipients must:**

1. Write a letter to the Northern Indiana Community Foundation by July 1 of each year requesting that the scholarship Selection Committee consider renewal of said scholarship. **(Failure to submit your renewal request letter by the July 1st deadline date shall forfeit his/her eligibility to re-apply for said scholarship for that particular scholarship year.);**
2. Attach a statement on the courses of study you completed the previous year;
3. Attach your course schedule for the new year; and,
4. Show proof of academic eligibility—Based on a 4.0 grading scale, current recipients must maintain a 2.25 Cumulative GPA or higher during his/her graduate school program. **(Failure of any recipient to maintain such academic achievement shall forfeit his/her eligibility to re-apply for said scholarship for that particular scholarship year.)**

SCHOLARSHIP SELECTION PROCESS:

The Frederick Rakestraw Law Scholarship Selection Committee along with members of The Fulton County Community Foundation Scholarship Committee shall select the recipients of this scholarship.
